COMMENCE AT THE SW CORNER OF SECTION 31, TOWNSHIP 12 SOUTH, RANGE 21 EAST, MARION COUNTY, FLORIDA; THENCE N. 00° 38' 05" W., ALONG THE WEST BOUNDARY OF THE SW 1/4 OF AFORESAID SECTION 31 A DISTANCE OF 659.91 FEET TO THE NW CORNER OF THE SOUTH 1/2 OF THE SW 1/4 OF AFORESAID SW 1/4 AND THE POINT OF BEGINNING; THENCE N. 89° 41' 58" E., ALONG THE NORTH BOUNDARY OF SAID SOUTH 1/2 OF THE SW 1/4 OF THE SW 1/4 A DISTANCE OF 1323.18 FEET TO THE NE CORNER OF SAID SOUTH 1/2 OF THE SW 1/4 OF THE SW 1/4; THENCE N. 00° 22' 54" W., ALONG THE EAST BOUNDARY OF AFORESAID SW 1/4 OF THE SW 1/4 A DISTANCE OF 38.17 FEET; THENCE N.89° 41' 58" E., 1364.70 FEET TO A POINT ON THE WESTERLY RIGHT OF WAY CURVE OF COUNTY HIGHWAY NO. 225 (100.00 FEET WIDE) CONCAVE TO THE WEST HAVING A RADIUS OF 1801.21 FEET AND A CENTRAL ANGLE OF 18' 25' 51"; THENCE NORTHWESTERLY ALONG SAID RIGHT OF WAY CURVE AN ARC LENGTH OF 579.41 FEET, WITH A CHORD BEARING AND DISTANCE OF N. 13° 45' 29" W., 576.92 FEET TO THE POINT OF TANGENCY OF SAID RIGHT OF WAY CURVE; THENCE N. 22° 58' 24" W., ALONG SAID WESTERLY RIGHT OF WAY LINE 1044.42 FEET; THENCE DEPARTING FROM SAID RIGHT OF WAY LINE S. 89° 36' 56" W., 2160.08 FEET TO THE AFORESAID WEST BOUNDARY OF THE SW 1/4 OF SECTION 31; THENCE S. 00° 38' 05" E., ALONG AFORESAID WEST BOUNDARY OF SW 1/4 OF SECTION 31 A DISTANCE OF 1559.82 FEET TO THE POINT OF BEGINNING
